2023 THE STUDENT CLINICIAN PROGRAM: A POSTER COMPETITION

The Student Clinician Program, conducted by <u>the Dental Association of Thailand</u> (hereafter D.A.T.) and sponsored by <u>Dentsply (International)</u>, provides the opportunity for <u>one student</u> from each accredited dental school in Thailand to receive an expense-paid trip to participate in the Annual Scientific Session of the Dental Association of Thailand and to compete for awards.

Definition of Program

The Student Clinician Program is a research competition, which emphasizes on presenting a research work containing clinical implication, not pure basic research. It must be orally presented completely in no more than 7 minutes to judges during period of the D.A.T. annual session. Vertical **digital** poster will be used for the presentation. When create the poster, please follow the maximum poster size of 85x120 cm (WxH).

Presenter must be able to provide the answers to these questions.

- What is the research question?
- What are the findings?
- What is the clinical application?

This is a presentation demonstrating methods and results of research which have immediate relevance to clinical dentistry. The work may show preventive, restorative, surgical or diagnostic procedures, or it may concern with materials or devices directly related to dental care, including research and/or advocates of a clinical technique as a result of that research.

Eligibility

The Student Clinician Program accepts the work done in the presenter's dental school, selected through a competition at his/her school, has never been awarded nationally or internationally except for awards from applicant's own faculty. Participants must be undergraduate students or graduated not more than one year at the time of presentation at the DA.T. Annual Session. Participants must not be graduate students at the time of presentation. The presentation may be developed by two or more students but only one student from each school is eligible to present for judging and receive financial support from Dentsply.

Invitation to Participate.

The initial letter of invitation to participate in the Student Clinician Program is forwarded to the Dean of each school. The Dean will indicate whether the school will participate and name the faculty advisor to whom future correspondence should be directed.

Regulations

- 1. The competition is a closed, onsite, oral presentation, and must be **presented in English** by one student only during judging.
- 2. Students must submit the application form with **a summary** of their work (an abstract) in English, maximum of 300 words in length containing:
 - a. Title: limit to 10 words or less
 - b. <u>Purposes or Objectives</u>: Identify reasons for investigation and provide brief background information.
 - c. <u>Methods</u>: Report how the study was conducted, identifying techniques, drugs, animals, etc.
 - d. <u>Results</u>: The bulk of information should be contained here, listing results of the study and their possible significances.
 - e. <u>Conclusion</u>: Provide definite conclusion of the study.
 - f. Keywords, provide at least 3 and no more than 5 keywords in alphabetical order.
 - g. Work must be subclassified into one of the following groups:
 - Behavioral, epidemiology and health services
 - Cariology
 - o Clinical & epidemiological studies
 - o Demineralization/remineralization
 - o Detection, risk assessment & others
 - o Erosion
 - o Fluoride & Ca-based products
 - o Microbiological studies/biofilm
 - Clinical and translational science network
 - Craniofacial biology
 - Dental anesthesiology and special care
 - Dental materials
 - o Ceramic-based materials
 - o Polymer-based materials
 - Meta-based materials and other materials
 - o Adhesion
 - o Biocompatibility, bioengineering and biologic effects of materials
 - o Instruments and equipment
 - Color and appearance (esthetics)
 - Clinical trials
 - Diagnostic science
 - Geriatric and special care
 - Implantology
 - Mineralized tissue
 - Neuroscience/pain
 - Oral/maxillofacial surgery
 - Periodontal tissue

- Pharmacology
- Pulp biology/regeneration
- Restorative dentistry

- **3.** Each presentation must be no longer than 7 minutes in length, allowing another 10 minutes for Q & A.
- 4. PDF file of the presentation must be electronically submitted to the D.A.T. by December 1st, 2023.
- 5. Substitution of presenter or significant changes in the title of presentations from that listed in the official program is not permitted.
- 6. No advertising material may be distributed nor any material shown, which in any way resembles a commercial promotional effort. Drugs and products mentioned in the presentation generally should be identified by chemical formula or by generic name. Trade names may be used for identification and clarification purposes only. Should the use of trade names be advantageous to the viewer's understanding of the presentation, the rationale should be submitted in writing to the Dental Association of Thailand 15 days in advance of the annual session requesting the Dental Association of Thailand approval. Commercial promotion of a product or service by trade name is absolutely prohibited.
- 7. All presenters must report to the competition room, <u>half an hour before the judging</u> session begins.
- 8. Only one presenter is permitted during the judging session.

ANY VIOLATION OF THE ABOVE REGULATIONS WILL AUTOMATICALLY DISQUALIFY THE STUDENT FROM COMPETITION.

Method of Selection

The Dental Association of Thailand does not designate a specific procedure for the selection of students. However, the Association does require each school to utilize the mechanism of a student competition conducted either by the student association or the school itself. It is acknowledged that each school has its separate set of rules or guidelines in the selection of the student winner. However, it must be understood that the student who participates in the program must adhere to the regulations established by the Dental Association of Thailand.

Expenses of Student Clinicians

Students selected by each school and accepted by <u>the Dental Association of Thailand</u> will receive from Dentsply (International), prior to the annual session, as followings:

1. One round trip transportation from the city where school is located.

- 2. One night of hotel accommodation
- 3. Allowance including meal and local transportation.

The expense (1-3) will be provided to students by D.A.T. upon arrangement with Dentsply (Thailand). Students are required to remain at the annual meeting for award presentation (time and location will later be provided).

Criteria Used for Judging

Judging is based on subject matter, presentation quality and style, questions and answers.

Registration at Annual Session

All students and advisors will be pre-registered, courtesy of the D.A.T. The badges will entitle them admission to scientific sessions, as well as the technical exhibition area.

Time of Presentation

Judging session (a closed session) starts <u>from 9.00 am on December 13th, 2023</u>. **Please** be reminded that only one presenter is allowed during judging.

Award Ceremony

Award ceremony takes place to honor all the students participating in the program. The students will receive the recognition they deserve as the official representative of their dental schools. Awards will be presented to winner and first runner-up. Invitations and RSVP cards will be forwarded directly to each student, dean and faculty advisors from Dentsply.

Awards

- 1. The 1st prize winner (one presenter) will receive an award from Dentsply including:
 - a. A travel prize to the American Association for Dental Research (AADR) Annual Meeting
 - b. His or her work will be as a part of the Scientific Program.
 - c. Transportation, hotel, hotel transportation and meal expenses are provided by Dentsply.
- 2. The 2nd prize winner will receive an award from the D.A.T. including:
 - a. 500 USD cash prize

Suggestions

The following suggestions are designed to assist students in the preparation:

- 1. Judges are looking for scientific/clinical substance, and are not impressed with sophisticated gadgets, etc.
- 2. A complete oral presentation in English must be no longer than 7 minutes.

3. The student should be prepared to answer questions regarding the presentation.

Responsibility of the School

Each eligible school is required to complete a form furnished by <u>the Dental Association of Thailand</u> indicating its desire to participate in the Student Clinician Program, listing the name of the faculty advisor who will assist the student in properly fulfilling the requirements of the program.

Responsibility of the Faculty Advisor

It is imperative that the faculty member appointed by the dean to serve as the advisor should make sure that every aspect of the student's presentation is in compliance with the regulations established <u>by the Dental Association of Thailand</u>. The advisor should also see that the student returns all completed forms by the due date.

*****Responsibility of the Participants

- 1. Complete and return all forms and necessary documents via online system furnished by the Dental Association of Thailand no later than 4 pm. of September 30th, 2023.
- 2. Submit an English abstract (maximum of 300 words) of the research work <u>to the Dental Association of Thailand</u> via provided online submission system.
- 3. Submit a recent formal photograph of the presenter <u>to the Dental Association of Thailand</u>, <u>online as a JPEG format with a resolution of at least 2 MB</u>.
- 4. PDF file of the presentation must be electronically submitted to the D.A.T. <u>by December</u> <u>1st</u>, <u>2023.</u>
- 5. Remain at the D.A.T. annual session for award presentation.
- 6. Pay incidental hotel charges when checking out (room service, phone calls, mini bar, etc). Note that an expense for shipment of materials for presentation is not available.

2023 D.A.T.-Oral Science Research Competition

The D.A.T.- Oral Science Research Competition, conducted and sponsored by <u>the Dental Association of Thailand</u> (hereafter D.A.T.), provides the opportunity for <u>one undergraduate student</u> from each accredited dental school in Thailand to participate in the Annual Scientific Session of the Dental Association of Thailand and to compete for an award.

Definition of Program

The D.A.T.- Oral Science Research Competition is <u>an oral presentation of research work, which emphasizes on basic oral science research</u>. It must be orally presented completely in no more than 7 minutes to judges during period of the D.A.T. annual session.

Presenter must be able to provide the answers to these questions.

- What is the research question?
- What are the new findings?
- What is the clinical implication?

The presentation must be demonstrating rationales, methods and results of research which have immediate *relevance to pre-clinical science basis to dentistry*.

Eligibility

The D.A.T.- Oral Science Research Competition accepts the work done in the presenter's dental school, selected through a selection process at his/her school, has never been awarded nationally or internationally except for awards from applicant's own faculty. Participants must be undergraduate students or graduated with a D.D.S. degree not more than one year <u>at the time of presentation at the D.A.T. Annual Session.</u> Participants must not be postgraduate students at the time of presentation. A presentation may be developed by two or more students <u>but only one student from each school</u> is eligible to present for judging and receive financial support from the D.A.T.

Invitation to Participate.

The initial letter of invitation to participate in the D.A.T.- Oral Science Research Competition is forwarded to the Dean of each school. The Dean will indicate whether or not the school will participate and name the faculty advisor to whom future correspondence should be directed.

Regulations

- 1. The competition is a closed, onsite, oral presentation session in English by one student only during judging. Vertical **digital** poster will be used for the presentation. When create the poster, please follow the maximum poster size of 85x120 cm (WxH).

Students are required to present their works to the judges only, in a closed session, from 13:00-16:00 on December 14th, 2023.

Expenses

The finalists will receive not more than 3,000 Baht/team, from the D.A.T., as travel expense to the annual session (500 Baht/team for the teams from Bangkok or vicinity e.g. Pathumthani, Samutprakan). Usual documents supporting travel expenses must be provided for reimbursement. Participants are required to stay in the hotel provided by the organizing committee and present at the annual meeting for award presentation (at 11:30-12:00 on December 15th, 2023).

Award Ceremony

Award ceremony takes place to honor all the student researchers participating in the program at the D.A.T. annual ordinary meeting at 11:30-12:00 on December 15th, 2023. The students will receive the recognition they deserve as the official representative of their dental schools. Awards will be presented to winners of the first and second prizes. Invitations and RSVP cards are forwarded directly to each student, dean and faculty advisors from the DAT.

Awards

The winners will receive awards from the D.A.T. including:

- 1. First prize winner (one presenter) receives a travel prize to the FDI Annual World Dental Congress, which his or her work is to be *presented* as a part of the FDI Scientific Program. Transportation, hotel, and meal expenses to the FDI World Dental Congress are provided by the D.A.T.
- 2. Second prize winner receives a 500 USD cash prize.

Suggestions

- 1. Judges are looking for scientific substance and are not impressed with sophisticated gadgets, etc.
- 2. A complete oral presentation in English must be no longer than 7 minutes.
- 3. The presenter should be prepared to answer questions regarding the presentation.

Responsibility of School

Each eligible school is required to complete a form furnished by <u>the Dental Association of Thailand</u> indicating its desire to participate in the program and listing the name of the faculty advisor who will assist the student in properly fulfilling the requirements of the program.

Responsibility of Faculty Advisor

It is imperative that the faculty member appointed by the dean to serve as the advisor should make sure that every aspect of the student's research presentation is in compliance with the regulations established <u>by the Dental Association of Thailand</u>. The advisor should also see that the student returns all completed forms by the due date.

- 3. PDF file of the presentation must be electronically submitted to the D.A.T. by $December 1^{st}$, 2023.
- 4. Remain at the D.A.T. annual session for award presentation.
- 5. Pay incidental hotel charges when checking out (room service, phone calls, mini bar, etc), if any.

2023 D.A.T. Graduate Research Competition

The D. A. T. Graduate Research Competition, conducted by the Dental Association of Thailand (hereafter D.A.T.), provides the opportunity for graduate students from accredited dental schools in Thailand to compete. The winners of the competition will receive the following awards:

- 1. First prize award: total amount of 100,000 Baht
- 2. Second prize award: total amount of 50,000 Baht

Definition of Program

The D.A.T. Graduate Research Competition is a research competition aiming for research work relevant or basis to dentistry. This is an oral presentation, demonstrating research question, rationale of the study, methods, and results of research works, which have immediate relevance to clinical dentistry.

Eligibility

The program accepts the work done, in the presenter's accredited Thai dental school, which has not been awarded nationally or internationally except for awards from applicant's own faculty. Participants must be graduate students or former graduate students, who have graduated not more than one year at the time of presentation at the D.A.T. Annual Session. The work may be developed by more than one student, but only one student from each group is eligible to compete.

Invitation to participate

The announcement of the D.A.T. Graduate Research Competition will be sent to all deans of the dental schools. The status of each applicant must be endorsed by the dean of the dental school he or she has attended.

Regulations

- 1. The competition is an oral presentation in front of judges. Each work must be presented in English by one presenter using PowerPoint or Keynote. The study must not be awarded from national/international competition or conferences.
- 2. Applicants must submit their applications along with a long or extended abstract of their work, not to exceed 2 A4 pages in length using size 12 Times New Roman font, typed in single space. The extended abstract must contain:
 - a. Title: limited to 10 words or less
 - b. Background and Objective(s) of the study
 - c. Materials and Methods: report how the study was conducted, identifying techniques, drugs, animals, etc.

- d. Results and Discussion: list the "NEW" findings and explain how your findings have made the advancement of science in dentistry. Explain how your findings will have an impact on clinical dentistry.
- e. Conclusion and Application: provide definitive conclusion of the study.
- f. Keywords: select no more than 5 keywords, in alphabetical order.
- g. Work should be sub-classified into one of the following groups:
 - Behavioral, epidemiology and health services
 - Cariology
 - Craniofacial biology/development
 - Dental materials
 - Dental education
 - Diagnostic science
 - Geriatric and special care
 - Implantology
 - Microbiology/immunology
 - Mineralized tissue
 - Neuroscience/pain
 - Oral/maxillofacial surgery
 - Periodontal tissue
 - Pediatric dentistry
 - Pharmacology
 - Pulp biology/regeneration
 - Restorative dentistry
 - Salivary research
 - Stem cell biology

Presenter must be able to provide the answers to these questions;

- What is the research question?
- What are the new findings?
- What is the clinical relevance?
- 3. Oral presentation will be in English and takes no longer than 10 minutes. Ten-minutequestion and answer session will follow.
- 4. Substitution of presenter or significant changes in the title of presentations from that listed in the official program is not permitted.
- 5. VDO clip is not allowed unless it is already impregnated in the presentation slide.
- 6. No advertising materials may be distributed, nor any material shown, which in any way resembles a commercial promotional effort. Drugs and products mentioned in the presentation generally should be identified by chemical formulas or by generic names. Trade names may be

used for identification and clarification purposes only. Should the use of trade names be advantageous to the viewer's understanding of the presentation, the rationale should be submitted in writing to the Dental Association of Thailand 15 days in advance of the annual session requesting the Dental Association of Thailand approval. Commercial promotion of a product or service by trade name is absolutely prohibited.

- 7. Presenters must report to the competition room 30 minutes before the judging session begins.
- 8. Only <u>one presenter</u> is permitted to present and answer questions during judging session.

ANY VIOLATION OF THE ABOVE REGULATIONS WILL AUTOMATICALLY DISQUALIFY THE COMPETITORS FROM COMPETITION.

Method of Selection

The Dental Association of Thailand will preliminarily screen the submitted abstracts. Only selected abstracts will go to the final round. It must be understood that the competitors who participate in the program must adhere to the regulations established by the Dental Association of Thailand.

Screening Criteria

Originality or Novelty	0-5
Research Design and Quality	0-10
Clinical relevance	0-2

The submitted work must receive scores in all categories. Five projects or less will pass to the final round and the scores must be 13 or higher.

The D.A.T. reserves the right to give final judgement, and the verdict is exclusive right of the D.A.T.

Expenses

Students will receive as followings:

- 1. One round trip transportation (not more than 3,000 Baht/team) or 500 Baht/team for the teams from Bangkok or vicinity (e.g. Pathumthani, Samutprakan)
- 2. One night of hotel accommodation (the night of Thursday, December 14th, 2023)

Students are required to remain at the annual meeting (December 15th, 2023 at 11:00 am) for award presentation

Usual documents supporting travel expenses must be provided for reimbursement. Participants are required to stay in the hotel provided by the organizing committee and present at the annual meeting for award presentation.

Criteria for Judging

Judgment is based on subject matter, research quality, quality of presentation, and the ability to answer questions.

Registration for the Annual Session

All presenters and advisors will be pre-registered with no cost, courtesy of the D.A.T. The badges will entitle them admission to all scientific sessions, as well as the technical exhibition area

Time of Presentation

Finalists are required to present their works to the judges from 13:00 to 16:00 on December 14th, 2023. Please be ready at the presentation room at 12:30.

Award Ceremony

Award ceremony takes place at the annual ordinary meeting of the association, usually in the main convention hall, to honor all finalists participating in the program. Awards will be presented to the first and second prize winners. Invitations and RSVP cards will be sent directly to each participant, dean, and research advisors.

AWARDS

The winner will receive an award from the D.A.T. including:

- 1. First prize 100,000 Baht (40,000 for advisor(s), 40,000 for winner, 20,000 for institution)
- 2. Second prize 50,000 Baht (20,000 for advisor(s), 20,000 for winner 10,000 for institution)
